*Carpenters Metropolitan Regional Council, Southeastern Pennsylvania, State of Delaware and Eastern Shore of Maryland (Adams-Bickel Associates, Inc.)* (4-CC-2463, 2482; 351 NLRB No. 51) Philadelphia, PA Oct. 18, 2007. The Board affirmed the administrative law judge's finding that the Respondent violated Section 8(b)(4)(ii)(B) of the Act in two instances by threatening neutral employers with the object of forcing the employers to cease dealing and doing business with certain primary employers and unspecified "unfair subcontractors." The Board also adopted the judge's finding that a broad cease-and-desist order was warranted. [\[HTML\]](#) [\[PDF\]](#)
