TO THE ADMINISTRATIVE LAW JUDGE'S DECISION**


COMES NOW the undersigned in representation of Counsel for the General Counsel and respectfully states and prays as follows:

1. The Administrative Law Judge, Honorable Paul Bogas, issued a Decision in the above-captioned case on February 8, 2008.
2. The deadline for filing Exceptions to the Decision of the Administrative Law Judge was initially March 7, 2008.
3. On March 3, 2008, the Respondent requested an extension of time to file exceptions to the Judge Bogas' Decision.


