Dear Executive Secretary Heltzer:

By this letter, Charging Party Southern California Painters and Allied Trades District Council No. 36, International Union of Painters and Allied Trades, AFL-CIO ("District Council 36") hereby respectfully requests a 15-day extension of time until February 10, 2009 to file its answering brief to Respondents' exceptions and its cross-exceptions. Good cause exists to grant this request.

Both Respondents Raymond Interior Systems and United Brotherhood of Carpenters and Joiners of America, Local 1506 and Southwest Regional Council of Carpenters, separately e-filed exceptions and supporting briefs on January 12, 2009. The issues involved in this matter are complex and were extensively briefed. District Council 36's lead counsel, Ellen Greenstone, will be out of town next week due to pre-scheduled travel plans. Further, intervening work that requires emergency attention further necessitates this request for an extension. This request is not sought for purposes of delay.

Counsel for the General Counsel, Patrick Cullen, Esq., and Counsel for Respondents Kathleen Jorgenson, Esq., and James Bowles, Esq., have been notified of this request and have indicated that they have no objection thereto.


