JOINT MOTION FOR EXTENSION OF TIME FOR THE PARTIES TO FILE POST HEARING BRIEFS UNTIL SEPTEMBER 29, 2009

The Charging Party, National Elevator Bargaining Association (“NEBA”) and the Respondent, International Union of Elevator Constructors, Local 8 (“IUEC, Local 8”), through their undersigned attorneys, hereby move pursuant to a joint agreement that the parties be allowed an extension of time to file their post-hearing briefs to, and including, September 29, 2009. In support of this motion, NEBA and IUEC Local 8 state as follows:

1. A hearing in this matter pursuant to Section 10(k) of the National Labor Relations Act was held over a two-day period before Hearing Officer Scott Smith of Region 20 on September 9 and 10, 2009 in San Francisco, California.
2. The parties ordered transcripts of the proceedings at the end of the hearing. The official Court Reporter advised the parties that it would likely take between 7 and 10 days before the transcript was ready. Thus, the parties will not have copies of the official transcript until after the seven day period for submitting briefs has expired.
3. The parties need the transcript in order to examine it prior to filing their briefs and to make appropriate citations to the record in their briefs.

4. The undersigned counsel for NEBA and IUEC Local 8 have spoken and agreed that the parties should file a joint motion for an extension until September 29, 2009 for the parties to file their briefs. The parties therefore agree to the relief sought in this joint motion.

5. The short extension of time requested should not materially delay the resolution of this matter.

WHEREFORE, the parties jointly request that the Board grant the motion and extend the time for filing post-hearing briefs in this matter until and including September 29, 2009.


