
1. By order dated July 12, 2011, the date for receipt of exceptions in Washington, D.C. was set as August 4, 2011.
2. Counsel for the Acting General Counsel, Shelley B. Plass anticipates that she will be unable to finalize the exceptions and brief by August 4, 2011, due to a heavy caseload and mandatory training on an Agency wide initiative.
3. The instant matters involve several close factual and legal issues that require careful and thorough briefing.
4. Counsel for Respondent was consulted and does not oppose the instant motion.

5. Thomas Frazier and Cecil Mack, the Charging Parties, have been notified about the instant request, and have not communicated any objections to it.

6. The instant request is not made with any dilatory objectives.

Based on the foregoing, the undersigned respectfully requests that the time for filing exceptions in these cases be extended to August 23, 2011.


