
**SUPPLEMENT TO OPPOSITION OF RESPONDENT TO ACTING GENERAL
COUNSEL'S MOTION FOR RECONSIDERATION OF THE BOARD'S ORDER
GRANTING RESPONDENT'S REQUEST TO RESCHEDULE HEARING**

During the evening of August 29, 2011, Respondent GCA Services Group, Inc. ("GCA Services Group") was served with the Supplement To Acting General Counsel's Motion For Reconsideration in which Counsel for Acting General Counsel states that the Regional Director has a pending request for authorization to seek Section 10(j) injunctive relief. So it is clear, GCA Services Group has not been asked for its position on the applicability of Section 10(j) injunctive relief in this case. Rather, GCA Services Group's position on the applicability of Section 10(j) relief was requested in two other cases, Case 28-CA-60620 and Case 28-CA-062481. No complaint has been issued in either of those cases; in fact, GCA Services Group was informed that many of allegations contained in Case 28-CA-60620 were being dismissed or withdrawn and the position statement in Case 28-CA-062481 is not yet due. If Section 10(j) relief is being considered in this case, of which GCA Services Group is unaware, the request is stale, and even if it were not, rescheduling the hearing on the Complaint to start several weeks later will have no impact on a request for Section 10(j) relief whether it be in this case or another case for which a complaint has yet to be issued.

For the foregoing reasons and the reasons given in the Opposition Of Respondent To Acting General Counsel's Motion For Reconsideration Of The Board's Order Granting Respondent's Request To Reschedule Hearing, GCA Services Group requests that the Motion for Reconsideration of the Acting General Counsel be denied.
