**MOTION FOR EXTENSION OF TIME TO FILE EXCEPTIONS
TO THE SUPPLEMENTAL DECISION**

Republic Services, Inc. (“Republic”) respectfully requests an additional two week extension, until Friday, June 15, 2012 for the parties to file exceptions to Administrative Law Judge Amchan’s Supplemental decision on remand.

1. On April 5, 2012 an initial request for an extension of time was made by counsel for Republic with no objection from the Union or counsel for the Acting General Counsel. This extension was granted by Associate Executive Secretary Roxanne L. Rothschild.

2. On April 19, 2012 counsel for the Union made a request for extension of time until May 4, 2012 which was granted on April 20, 2012 by Associate Executive Secretary Henry S. Breiteneicher.

3. On May 3, 2012 counsel for Republic made a request for an extension of time until May 18, 2012 which was granted on May 4, 2012 by Henry S. Breiteneicher, Associate Executive Secretary.

4. On May 17, 2012 counsel for Republic made a request for an extension of time until June 1, 2012 which was granted on May 18, 2012 by Henry S. Breiteneicher, Associate Executive Secretary.

5. This extension request is being made for the sole purpose of aiding a global labor settlement between Republic and Local 150.

6. An additional two week period of time is needed to obtain the signatures of the individual employees who were Grievants in the Arbitration Awards or may be impacted by the pension and health and welfare provisions and ancillary documents related to the global settlement

7. On May 31, 2012 counsel for Republic contacted counsel for the Acting General Counsel and counsel for Local 150 about this extension request. They do not object.

8. No party will be prejudiced by this additional extension.

WHEREFORE, Republic Services, Inc. respectfully requests a two week extension, until Friday, June 15, 2012 to file exceptions to the Supplemental Decision.
