**JOINT MOTION FOR EXTENSION OF TIME TO FILE
EXCEPTIONS AND SUPPORTING BRIEFS**

Pursuant to Section 102.46(a) of the Board’s Rules and Regulations, Counsel for the General Counsel and Respondent First Student, Inc. hereby jointly move for an order extending the deadline for filing exceptions to the Decision issued in these cases on August 10, 2012 by Administrative Law Judge Mark Carissimi, and supporting briefs, from September 7, 2012, to September 21, 2012. As grounds for this motion, the movants submit that they are in the process of finalizing a tentative agreement they have reached settling all matters at issue in these cases but that they may not complete the process before the current deadline for filing exceptions and supporting briefs expires. Extending the deadline by two weeks will provide them ample time to finalize the agreement as well as, in the unlikely event the settlement is not effectuated, complete preparation of any exceptions and supporting briefs they may choose to file.

An email was sent to Counsel for the Charging Party, Sorrell Logothetis, on September 4, 2012, informing him that Counsel for the General Counsel and Respondent intended to file this

motion and inquiring whether Charging Party had any objection to its being granted. As of the time this motion was filed, Mr. Logothetis had not responded to the inquiry.
