**COUNSEL FOR THE ACTING GENERAL COUNSEL'S
MOTION TO CORRECT APPENDIX A OF BOARD'S DECISION AND ORDER**

Pursuant to Sections 102.47, 102.48 and 102.49 of the National Labor Relations Board's Rules and Regulations, the undersigned Counsel for the Acting General Counsel moves that the Board modify its Decision and Order in the above cases, reported at 358 NLRB No. 163 (September 28, 2012), to correct apparent inadvertent typographical errors in the 9th and 10th "WE WILL NOT" paragraphs of Appendix A, the Notice to Employees, 358 NLRB No. 163, slip op. at p.4, so those paragraphs conform to paragraphs 1(i)(i) and 1(i)(ii) of the Order, 358 NLRB No. 163, slip op. at p.3, and read as follows:

WE WILL NOT lay off unit employees without first notifying the Union and giving it an opportunity to bargain regarding the decision to lay off service technicians in the unit represented by the Union and the effects of that decision.

WE WILL NOT unilaterally suspend skill level reviews, thereby denying promotions to employees who would have been promoted if those reviews had occurred, without first notifying the Union and giving it an opportunity to bargain.

Counsel for the Acting General Counsel respectfully requests that the Board issue a modified Decision and Order including the above-described corrections.
